1. Full session charges will apply if you choose not to send your child to Little Lawrence's due to a holiday, medical appointment, play date or similar.
2. Full session charges will apply if your child does not attend Little Lawrence's due to illness.
3. Full session charges will still apply if Little Lawrence's has to close due to unforeseen circumstances, such as snow. This would be reviewed in the event of closure over longer periods.
4. Sessions should be paid up front on a weekly, monthly or half termly basis (at the published rates), with the exception of customers using childcare vouchers where payments are split over twelve months.
5. A 4 week notice period is needed for paying parents to terminate your contract.
